Feb. features medical skin care, aesthetics

She interned in combined medicine and surgery at Marshall University School of Medicine. As a resident, she received training in anesthesiology at Baylor Medical School in Houston. She was mentored for three years in aesthetic medicine by physicians around the U.S.

Dr. Michelle Berry went to Texas A&M University, where she received a bachelor's degree in business administration. She attended Kansas City University of Medicine & Biosciences, where she received her doctor of osteopathy. She opened Medical Center West (her family practice) in Boerne in 1994. She opened Care Choice in 2003 and Allure Laser & Skin Clinic in 2005.
